## Family Digital Wellness Online Cohort Program

Pennsylvania Family Support Alliance (PFSA) is excited to announce the launch of the **Family Digital Wellness Online Cohort** (**FDW-OC**), a new and unique training program and professional development opportunity extended to professionals in child and familyserving fields who have an enthusiastic interest in learning and discussing how digital wellness plays a role in the lives of families within each of our communities. At its foundation, the FDW-OC is a space where professionals can come together to expand their capacity for creating safe and healthy interactions with digital technology rather than choosing a restrictive and limited approach. It is also where we can learn the skills and understand the experiences that impact our relationship with digital technology.

This program will follow a cohort structure, and all sessions will take place virtually via Zoom between September and February:

- Two monthly group content sessions (2 hours each)
- One monthly individual assignment
- Group discussions

#### **Applications Now Open!**

Applications for the FDW-OC are now being accepted! The final deadline for all applications to be considered is August 30, 2024, by 12 p.m. Eastern time. Once submitted, your application will be reviewed, and you will be notified of your acceptance status within one week.

If your application is accepted, we will reach out to you to confirm your acceptance and

attendance in the program. Additional information will follow this outreach.

## MANDATED REPORTER TRAINER SPOTLIGHT Melissa Haydt

We recently interviewed Melissa, who has been a contracted trainer for PFSA since 2003 here is what she has to say about why she is so passionate about training mandated reporters.

## Why do you care about mandated reporters of child abuse?

I care about mandated reporters because these are the professionals on the front line. These are the individuals who often see and identify child abuse in our children before anyone else. Oftentimes, if it wasn't for them, child abuse would not be identified, reports would not be made, and children would not be protected. By training mandated reporters, they can learn the latest about what is going on in the field of child abuse and develop and enhance their skills to identify child abuse.

I love interacting with all the mandated reporters during training. They are a very diverse group. I love learning about them and their professions, as well. If it were not for our mandated reporters, many more children would be seriously injured or die as a result of child abuse. My work and training for all these many years has been for the motto of the Starfish Story, which is that "we may not



be able to save all children from child abuse, but we can make a difference for this one."

#### Why do you train for PFSA?

I train for PFSA because I have a passion for working in the field of child protection and doing what I can to keep children safe. My entire career, which began in May 1975, has been spent working with children and their families and perpetrators, all for the purpose of protecting children and keeping them safe. I train for PFSA because I love sharing my knowledge and experience in the field of child abuse with mandated reporters.

We appreciate the wealth of knowledge Melissa brings to each training she provides to mandated reporters. She looks forward to meeting you in her trainings!

# **UPCOMING PFSA TRAININGS**

## Families in Recovery New Facilitator Training

This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The program aims to teach healthy coping and parenting skills while balancing the needs of recovery.

New facilitators of the Families in Recovery (FiR) program will be fully prepared to implement the program and provide training after attending a two-day comprehensive session consisting of content, education, and application instruction of the curriculum. FiR facilitators come together to share program implementation experience, ideas, and insights following initial training.

All organizations interested in implementing the Families in Recovery program are required to enter an agreement contract with PFSA and participate in the evaluation requirements of the program. FiR contracts include ongoing technical assistance, program development, facilitator calls, and assistance with data collection procedures.

Certificates are provided to the participants, and, upon request, we will upload confirmation of your training to the Departments of State or Education for CE fulfillments under Act 31 and/or Act 48. #### **TRAIN-THE-TRAINER**
