# **Cindi Horshaw**


We recently interviewed Cindi, who has been a contracted trainer for PFSA since 2017. Here is what she has to say about why she is so passionate about training mandated reporters.

### Why do you care about mandated reporters of child abuse?

Mandated reporters play a critical role in helping to protect the most vulnerable citizens of Pennsylvania - children. Many of our mandated reporters spend more time with children than anyone and they have the ability to identify potential victims of abuse and neglect early so that we can take steps to ensure the safety of children. I have always been passionate about child welfare work and being able to train mandated reporters is one small way I can give back and arm mandated reporters with the knowledge and skills they need to play their part! Together we can all make a difference in the lives of children!

### Why do you train for PFSA?

I train for PFSA because my entire career has been in child welfare, and I am passionate about the work the child welfare system does and the responsibility they have to protect children. I feel it is incredibly important to make sure that mandated reporters understand their roles and



Understanding the law and being able to recognize and report suspected child abuse requires individuals to be well informed and educated, otherwise we leave children in unsafe situations. The training PFSA provides eliminates the excuse of "I didn't know what I was supposed to do" or "I didn't know how to report" and ensures every mandated reporter has the opportunity to become educated on their reporting obligation in order to play their small part in protecting children.

# Family Digital Wellness - Online Cohort Training Program

Apply today for the Family Digital Wellness-Online Cohort (FDW-OC). The training is a unique opportunity for professionals in child and family-serving fields who have an interest in learning about how digital technology impacts communities and discussing how digital wellness can positively impact the lives of children and families that we serve. The FDW-OC provides a way for professionals to come together and expand their capacity for helping families create safe and healthy interactions with digital technology.

This program will follow a cohort structure, with all sessions taking place virtually via Zoom between August 2025 and January 2026:

- One Monthly Group Content Session
- Individual Assignments
- ► Group Discussions

# Families in Recovery (FiR) New Facilitator Training

This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The program aims to teach healthy coping and parenting skills while balancing the needs of recovery.

New FiR facilitators will be fully prepared to implement the program and provide training after attending a two-day session that covers content, education, and implementation of the curriculum. FiR facilitators come together during training to share program implementation experience, ideas, and insights.

All organizations interested in implementing FiR are required to enter into a contract with PFSA and participate in the evaluation requirements of the program. Contracts include ongoing technical assistance, program development, facilitator calls, and assistance with data collection.
