How to Talk to Children About Racism and Injustices

Children notice and can understand at an early age when people suffer injustices, and yet parents often don't talk about this important topic with their children. **Discussing racism and slavery can be especially difficult, but we NEED to talk about them.** Learning about their history can help young Black children develop a positive racial identity, provided the education is done in an uplifting, empowering, and inclusive manner. For young white children, learning about historical racism and slavery interrupts any false sense of racial superiority.

If we choose not to talk about racism, our silence is still talking about it — but in a way that our kids learn to ignore or dismiss the importance of it and potentially create incorrect thoughts and biases about racism.

CONVERSATION IS KEY!

Try to make the conversation with your children natural and comfortable, so your kids feel free to ask questions. If you are not sure about an answer, look it up and get back to them with the answer. You do not know what questions they have until they ask them. Although some questions (such as "will we ever be slaves again?" or "were my relatives slave owners?") may be difficult to hear, kids need the space and time to ask as they learn and process all the information. Be sure to check in on how they feel about these big concepts too.

CONVERSATIONS HELP ALL OF US!

Discussing race and diversity helps children develop a healthy appreciation of differences between people. By raising the next generation to appreciate and build on these differences, we can become stronger together.

TURN PENNSYLVANIA BLUE 4.2.24

Blue is the national symbolic color of child abuse prevention. On April 2, PFSA encourages everyone to wear blue and use their voices and platforms to help raise awareness about child abuse prevention to "Turn Pennsylvania Blue."

FLAG PLANTING ON THE GROUNDS OF THE CAPITOL 4.2.24

On April 2, PFSA will once again sponsor this in-person event in Harrisburg, PA. From Front Street to the steps of the Capitol, PFSA staff members, board of directors, statewide and local advocates, officials, and corporate supporters will plant 4,992 blue flags to represent the number of substantiated child abuse cases and 60 black flags to represent the number of child deaths due to child abuse in Pennsylvania over one year.

UPCOMING PFSA TRAININGS

Families in Recovery New Facilitator Training

This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The program aims to teach healthy coping and parenting skills while balancing the needs of recovery.

New facilitators of the Families in Recovery (FiR) program will be fully prepared to implement the program and provide training after attending a two-day comprehensive session consisting of content, education, and application instruction of the curriculum. FiR facilitators come together to share program implementation experience, ideas, and insights following initial training.

All organizations interested in implementing the Families in Recovery program are required to enter an agreement contract with PFSA and participate in the evaluation requirements of the program. FiR contracts include ongoing technical assistance, program development, facilitator calls, and assistance with data collection procedures.
