

PA Blue Ribbon Champions for Safe Kids

Join us in April 2021 as we focus on how each of us can help prevent child abuse in Pennsylvania and be a champion for safe kids. This year we will have ways to engage virtually throughout the month of April via media efforts, primary prevention messaging, and virtual blue ribbon events to not only help all citizens realize the magnitude of child abuse and neglect in PA, but also inform how they can make a positive impact for change.

Mandated Reporter Training

PFSA has several options for you and your staff to receive training on how to recognize and report suspected child abuse. This training is for those mandated by law to report suspected child abuse, as defined in the Child Protective Services Law.

Curriculum is approved by the Departments of Human Services, Education, and State, and meets all requirements for mandated reporters to receive training in recognizing and reporting child abuse (including ACT 126). Certificates are provided to the participants, and (upon request) we will upload confirmation of your training to the Department of State or Education for CE fulfillments under ACT 31 and/or ACT 48. New this year — this curriculum has also been approved for CLEs for attorneys!

TRAIN-THE-TRAINER (TTT)

This is an opportunity for organizations to develop their own quality, cost-efficient, in-house training program for employees on child abuse recognition and reporting. With the three-year contract, PFSA provides two days of initial instruction for approved applicants, reports CEs directly to the PA Departments of State and Education, and offers ongoing technical assistance.

Cost: \$1,000 per trainer entering into a 3-year contract with PFSA (payment can be broken down by year — \$400/year 1, \$300/year 2, and \$300/year 3)

Front Porch Project

When PFSA launched a community-based program called the *Front Porch Project* (FPP), it was with the purpose to educate communities across Pennsylvania on how to identify, and safely intervene, when a child is unsafe.

This program was built on the belief that everyone can — and should — play a role in preventing child abuse and supporting families. From giving important statistical information to fostering in-depth discussions and highlighting real-life examples, PFSA strives to increase understanding and knowledge of child abuse and neglect, so that everyone is equipped with the tools they need to support and protect children and families in their communities.

Our train-the-trainer (TTT) model for FPP is now available in virtual format. Although these trainings will also be available in person in the near future, we've shifted gears to provide a virtual delivery method during the pandemic. We have also made recent revisions to the curriculum and activities for more relevant and engaging content.

As we enter the new year, PFSA will continue to hold brief overview sessions for anyone who is interested in learning more about the program. These sessions will be held every other Thursday at 10 a.m. beginning January 14, 2021. Families in Recovery

In late January, PFSA will host a two-day train-the-trainer (TTT) session for our *Families in Recovery* program. This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The goal of this program is to teach healthy coping and parenting skills while balancing the needs of recovery.

Organizational trainers will be fully prepared to provide training after attending a two-day comprehensive session consisting of content, education, and application instruction of the curriculum. TTT contracts include ongoing technical assistance, development, and coaching webinars, and assistance with outcomes-driven data collection. TTT cohorts remain in contact with each other to share program implementation experience, ideas, and insights following initial training.

Cost: \$1,000 per trainer entering into a three-year contract with PFSA.
