3 Questions To Ask YOUR Child's Summer Camp

Keeping our children safe from abuse must be the highest priority throughout the year. Here are some questions you can ask your child's summer camp staff to find out what they are doing to #ProtectPAKids. We've also included tips you can pass on to the camp to improve child protection policies.

► Do all the staff and volunteers working with children have their child abuse and criminal background clearances? In many instances, criminal background clearances are required by law for those working or volunteering with children.

Tip for camps: Know the laws and consider going above the minimum requirement in the law to ensure all those who have contact with kids have no history of abusing children.

Do you have a child protection policy? Summer camps should have child protection policies that use known prevention strategies. For example, limit interactions between one adult with one child — ensuring that two adults are always present with children increases accountability and lessens the opportunity for abuse.

Tip for camps: PFSA has a sample child protection policy and is open to reviewing such policies to ensure they use known prevention strategies.

What training do the staff and volunteers receive regarding child abuse identification and reporting? Summer camps should provide comprehensive training for staff and volunteers on child abuse identification and reporting, so they know what to do when they suspect child abuse.

Tip for camps: PFSA provides free training on how to recognize and report child abuse, featuring relevant scenarios. Schedule a free onsite training today at pa-fsa.org.

Implementing child protection policies can be costly, but it's necessary. We must always focus on zero tolerance for the maltreatment of children, which requires a high level of honesty and transparency throughout an organization.
