## Kinship Care in Pennsylvania

When grandparents, other relatives (such as aunts and uncles), or family friends care for children because their parents are unable to care for them, it is called kinship care. It is difficult to know exactly how many children are in kinship care because many of them are not involved with the child welfare system.

During a recent presentation at PFSA's Child Abuse Prevention Symposium, Grandfamilies & Kinship Support Network reported that there are at least 68,000 children being raised by kin in Pennsylvania, with 235,515 grandparents being responsible for their grandchildren. Whether the arrangement is created formally through child protective services or informally within a family, kinship care benefits children because it reduces the trauma of family separation and provides cultural and community ties. It also reduces the need for reentry into foster care and improves permanency through a higher rate of guardianship, custody, and adoption by kinship care providers.

#### According to www.grandfamilies.org,

children in kinship homes also have better behavioral and mental health outcomes. In fact, studies have shown that children in kinship care have fewer behavioral problems three years after placement than children placed into traditional foster care. Relatives are more likely than nonrelatives to support the child through difficult times and less likely to request the removal of difficult children. Children tend to feel better about the placement and are less likely to run away.

More work can and should be done to support kinship care providers, especially grandparents raising grandchildren.

# **UPCOMING PFSA TRAININGS**

## Families in Recovery New Facilitator Training

This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The program aims to teach healthy coping and parenting skills while balancing the needs of recovery.

New facilitators of the Families in Recovery (FiR) program will be fully prepared to implement the program and provide training after attending a two-day comprehensive session consisting of content, education, and application instruction of the curriculum. FiR facilitators come together to share program implementation experience, ideas, and insights following initial training.

All organizations interested in implementing the Families in Recovery program are required to enter an agreement contract with PFSA and participate in the evaluation requirements of the program. FiR contracts include ongoing technical assistance, program development, facilitator calls, and assistance with data collection procedures.
