### Cybersecurity Awareness Month

Dating back to 2004, the president of the United States and Congress have deemed October Cybersecurity Awareness Month, a month dedicated to raising awareness about the importance of cybersecurity across all sectors of business and community. Unfortunately, surveys show most Americans think online security is confusing and challenging.

To counter that perception, the **Cybersecurity** and Infrastructure Security Agency (CISA) and the National Cybersecurity Alliance created this year's messaging with an eye to simplicity. The theme: "It's easy to stay safe online." Over the last few years and especially since the onset of the pandemic, we have heard more about the difficulties of children staying safe online and avoiding the negative impacts of technology use – especially social media.

Cybersecurity is just one piece of the puzzle when it comes to staying safe online, and few families are readily equipped with the information and resources necessary to prioritize online safety. More work must be done to help families create a willingness and capacity for safe and healthy interactions with technology.

The **Family Digital Wellness** initiative from **Pennsylvania Family Support Alliance** (PFSA) helps bridge the gaps for families between online safety, technology-related boundaries, and overall wellness. Our online Family Digital Wellness hub is a one-stopshop for parents and caregivers to remain informed about things related to digital safety and wellness happening in Pennsylvania and across the nation. Furthermore, PFSA has created free downloadable resources parents and caregivers can use to begin taking steps toward digital wellness.

Our most comprehensive resource, the **Family** Digital Wellness Parent Toolkit, includes more than 40 pages of information, activities, and resources, plus a framework to guide families on a journey of creating safe and healthy interactions with digital technology.

# **UPCOMING PFSA TRAININGS**

### Families in Recovery New Facilitator Training

This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The program aims to teach healthy coping and parenting skills while balancing the needs of recovery.

New facilitators of the Families in Recovery (FiR) program will be fully prepared to implement the program and provide training after attending a two-day comprehensive session consisting of content, education, and application instruction of the curriculum. FiR facilitators come together to share program implementation experience, ideas, and insights following initial training.

All organizations interested in implementing the Families in Recovery program are required to enter an agreement contract with PFSA and participate in the evaluation requirements of the program. FiR contracts include ongoing technical assistance, program development, facilitator calls, and assistance with data collection procedures.
