MANDATED REPORTER TRAINER SPOTLIGHT Ruth Zook

We recently interviewed one of our Amish trainers, Ruth Zook. Ruth has been instrumental in getting mandated reporters within the Plain Community trained – many for the first time – so they know how to recognize and properly report suspected child abuse within their community. Here is what Ruth has to say about why she is so passionate about training.


Why do you train for PFSA?

I train for PFSA because I see a need for awareness, education, and understanding of child abuse within my community. If people really understand what child abuse is, and how it affects people, they will stand up against it and do what they can to help children in those situations.

Why do you care about mandated reporters of child abuse?

I care about mandated reporters of child abuse because I want them to know what that means and how they can help when abuse happens. Mandated reporters have a responsibility that should not be shirked. Too many people do not realize or understand what it all means to be a mandated reporter, however, they have a right to that information and should be informed.

We appreciate the wealth of knowledge Ruth brings to each training she provides to mandated reporters within the Plain Community.

UPCOMING PFSA TRAININGS

Families in Recovery (FiR) New Facilitator Training

This research-based program is a great resource for parents, guardians, and caretakers recovering from substance use disorder. The program aims to teach healthy coping and parenting skills while balancing the needs of recovery.

New FiR facilitators will be fully prepared to implement the program and provide training after attending a two-day session that covers content, education, and implementation of the curriculum. FiR facilitators come together during training to share program implementation experience, ideas, and insights.

All organizations interested in implementing FiR are required to enter into a contract with PFSA and participate in the evaluation requirements of the program. Contracts include ongoing technical assistance, program development, facilitator calls, and assistance with data collection.

Mandated Reporter **Training**

PFSA has several options for mandated reporter training for staff and volunteers. We provide certificates to participants and, upon request, will upload confirmation of the training to the Departments of State or Education for CE fulfillments under Act 31 and/or Act 48. CLEs are also available for attorneys.

This is an opportunity for organizations to develop their own quality, cost-efficient, in-house training program for employees on child abuse recognition and reporting.
